REPORT BY MEXICO AS THE CURRENT PRESIDENT OF THE COUNCIL IN CHARGE OF THE SECRETARIAT GENERAL OF OPANAL

FROM SEPTEMBER 1 TO OCTOBER 31

In accordance with Resolution C/Res.43 "Interim Functions of the Council in view of the Resignation of the Secretary General," approved at the 51st Special Session of the Council on June 28, 2007, Mexico occupied the rotating presidency of the Council from September 1, to October 31. The following is a report of the activities undertaken during the months of September and October.

I. Collection of Contributions
