

#### RESOLUTION 95 (V)

## Creation of other Denuclearized Zones and their possible future relations with OPANAL

### The General Conference,

Having studied the Memorandum of the Secretary-General submitted in document CG/150;

Recalling Resolution 84 (IV) of the General Conference, adopted on April 18, 1975;

Taking note with satisfaction of the co-operation given by the Secretary-General of the Agency to the Working Governmental Group of Experts of the Conference of the United Nations Disarmament Committee for the study on matters related to nuclear-weapons-free zones in all its aspects:

Considering the positive attention given by the United Nations General Assembly in its Resolution dated December 10, 1976 (31/70) to the Report on this matter prepared by the Agency for the Prohibition of Nuclear Weapons in Latin America;

Whereas the above mentioned resolution of the General Assembly concerning the comprehensive study on the matter of nuclear-weapons-free zones and the Report of the Secretary-

General (Doc. A/31/189 and Adenda 1 and 2) forwarded to the international bodies so that they might consider new studies and measures within their respective field of competence;

Recalling the definitions of nuclear-weapons-free zones as well as the obligations of nuclear powers included in Resolution 3472 B (XXX), 1975 of the United Nations General Assembly which are in accordance with the elements and characteristics of the nuclear-weapons-free zone established by the Treaty of Tlatelolco;

Bearing in mind that in the lapse between Resolution 84 (IV) of the General Conference and the present resolution no other nuclear-weapons-free zones have been conventionally created;

Bearing in mind also that the United Nations General Assembly in Resolution 3472 B (XXX) solemly adopted a Declaration defining both the concept of nuclear-weapons-free zone and the scope of the main obligations of States who possess nuclear weapons.

### Resolves:

- 1. To express to the Secretary-General its appreciation for the co-operation given in the preparation of the Report of the special Working Governmental Group of Experts of the Conference of the United Nations Disarmament Committee on the study of matters concerning nuclear-weapons-free zones in all its aspects.
- 2. To adopt the definition of a nuclear-weapon-free zone and the definition related to the obligations of States possessing nuclear weapons established in Resolution 3472 B (XXX) of the United Nations General Assembly.

3. To request the Secretary-General to continue giving his widest co-operation to continue the overall study on matters related to the establishment of nuclear-weapons-free zones in other regions of the world in the light of the experience of OPANAL.
