## Resolution

## Control System: compliance with Article 24 of the Treaty of Tlatelolco

## The General Conference,

**Considering** that Article 24 of the Treaty for the Prohibition of Nuclear Weapons in Latin America and the Caribbean (Treaty of Tlatelolco) establishes that "the Secretariat shall be notified immediately of any international agreement concluded by any of the Contracting Parties on matters with which this Treaty is concerned; the Secretariat shall register it and notify the other Contracting Parties",

**Bearing in mind** that Article 24 is a legally-binding obligation for all Member States of the Agency for the Prohibition of Nuclear Weapons in Latin America and the Caribbean (OPANAL),

**Recalling** that Article 24 is an integral part of the Control System established by the Treaty of Tlatelolco,

**Reaffirming** that the provisions of the Treaty of Tlatelolco are an indivisible whole and, therefore, compliance with obligations resulting from said provisions is essential for the enforcement of the Nuclear-Weapon-Free Zone in Latin America and the Caribbean,

**Considering** the General Conference Resolutions 33 (II) of 9 September 1971, 53 (III) of 23 August 1973, 83 (IV) of 18 April 1975, 101 (V) of 21 April 1977, 118 (VI) of 25 April 1979, 143 (VII) of 24 April 1981, 169 (VIII) of 18 May 1983, 192 (IX) of 8 May 1985, 219 (X) of 29 April 1987, 248 (XI) of 27 April 1989, 277 (XII) of 10 May 1991, 297 (XIII) of 27 May 1993, 329 (XIV) of 29 March 1995, 356 (XV) of 10 July 1997, CG/Res.385 of 30 November 1999, CG/Res.414 of 29 November 2001, CG/Res.442 of 5 November 2003, CG/Res.474 of 8 November 2005, and CG/Res.05/2015 of 26 November 2015;

## **Resolves:**

- 1. **To reiterate** to the Governments of the Member States the need for a strict compliance with Article 24 of the Treaty of Tlatelolco and with the Resolutions adopted by the General Conference on the subject.
- 2. **To remind** the Governments of the Member States of the importance to comply with Article 24 notably on the occasion of the 50<sup>th</sup> Anniversary of the Treaty of Tlatelolco to be commemorated on 14 February 2017.
- 3. **To urge** the Governments of the Member States to notify the Secretary-General, when appropriate, of any conventions or agreements concluded on matters related to the Treaty of Tlatelolco, either bilaterally or multilaterally, either between Member States or with third parties, such as States or international organizations.
- 4. **To instruct** the Secretary-General to maintain the Council and the General Conference informed about the status of compliance with Article 24 of the Treaty of Tlatelolco.
