Nominations of Member States for the Council for the 2018-2021 term

- 1) The Treaty for the Prohibition of Nuclear Weapons in Latin America and the Caribbean Treaty of Tlatelolco establishes in Article 10, paragraphs 1 and 2 that:
 - 1. The Council shall be composed of five Members of the Agency elected by the General Conference from among the Contracting Parties, due account being taken of equitable geographic distribution.
 - 2. The Members of the Council shall be elected for a term of four years. However, in the first election three will be elected for two years. Outgoing Members may not be reelected for the following period unless the limited number of States for which the Treaty is in force so requires
- 2) On 31 December 2017, two Members of the Council, those being Mexico and Paraguay, will complete their mandate. They were elected for the 2014-2017 term, through Resolution CG/Res.565 entitled "Election of Members of the Council" (XXI Special Session held on 7 November 2013).
- 3) Brazil, Guatemala and Peru will continue to serve as Members of the Council until 31 December 2019, pursuant to General Conference Resolution CG/Res.09/2015 (XXIV Session held on 26 November 2015).
- 4) In the light of the above, the General Conference shall elect two Members of the Council for a four-year period, from 1 January 2018 to 31 December 2021, at its XXV Special Session, as established in Articles 62 and 63 of the Rules of Procedure of the General Conference, which read as follows:

Art. 62 The General Conference shall elect five Members of the Council from among the Member States, due account being taken of equitable geographic distribution.

Art. 63 The Member States of the Council shall be elected for a term of four years and shall not be re-elected for the immediately subsequent term.

- 5) The Secretariat presented Document C/06/2017, "Election of two Members of the Council for the 2018-2021 term", to the Council at its 307th Meeting held on 6 April 2017. The purpose of said document was to extend an invitation to Member States to present themselves as candidates for the Council.
- 6) On 10 July 2017, the Secretariat sent note number S-528/2017 informing Member States that the Government of Uruguay, through note number E.15/017-094 of the Embassy of Uruguay in Mexico, dated 3 July 2017, presented its nomination as candidate for the Council.
- 7) On 17 August 2017, the Secretariat sent note number S-645/2017, extending again the invitation to Member States to present themselves as candidates for the Council.
- 8) On 29 August 2017, the Secretariat sent note number S-685/2017 informing Member States that the Government of Argentina through note number EMEXI 5049/2017, dated 29 August 2017, presented its nomination as candidate for the Council.
